

**ROOT CREEK WATER DISTRICT**  
**RESOLUTION NO. 2012- 04**

WHEREAS, the Root Creek Water District (the “District”) is a water district organized under the California Water District Law, codified by California Water Code section 34000 *et seq.*;

WHEREAS, the District has obtained grant funding from the California Department of Water Resources (“DWR”) in the amount of Nine Million Four Hundred Thirteen Thousand Nine Hundred Forty-Seven Dollars (\$9,413,947) under the terms of that certain Grant Agreement dated June 5, 2012, by and between RCWD and DWR, as it may be amended from time to time;

WHEREAS, the funds provided under the Grant Agreement are for the purpose of implementing components of the San Joaquin River Integrated Regional Water Management Plan (“IRWMP”); specifically, the Madera Region Integrated Water Management Plan (“IRWM”);

WHEREAS, pursuant to the Grant Agreement, the District is required to ensure compliance with applicable California Labor Code requirements, including, but not limited to, Section 1720 *et seq.* of the California Labor Code regarding public works, limitations on use of volunteer labor (California Labor Code Section 1720.4), labor compliance programs (California Labor Code Section 1771.5) and payment of prevailing wages for work done and funded by this Grant, including any payments to the Department of Industrial Relations pursuant to California Labor Code Section 1771.3;

WHEREAS, in compliance with these DWR and Grant requirements, the District has prepared a Labor Compliance Manual outlining the District's Labor Compliance Program ("LCP") and ensure labor compliance standards are appropriately noticed and followed; and

WHEREAS, the District has also prepared a Labor Compliance Application that will be submitted with the District's Labor Compliance Manual for DWR's approval.

NOW, THEREFORE, BE IT RESOLVED that:

1. The District approves and adopts the LCP as outline in the Labor Compliance Manual; and
2. The District approves the Labor Compliance Application and requests that it be submitted to DWR with the District's Labor Compliance Manual.
