## NOTICE TO PROPERTY OWNERS OF PUBLIC HEARING March 13, 2023 at 12 pm Meter Installation Fees Construction Inspection Fees

## Overview

The Root Creek Water District (District) sustainably manages groundwater resources to provide available water supply for Agricultural and Municipal customers within the District. The District provides storm and sewer services to municipal customers. The District intends to adopt and increase in inspection rates to recover the District's share of providing inspection of construction activities.

A Miscellaneous Service Fees Report (October 2017) fairly determined the costs and rates for conducting inspections of construction activities and facilities within the District boundary. Increased labor costs have caused an increase in construction inspection rates. Increased costs from the meter supplier have prompted an increase in the meter fees. The costs found in Table 1. and Table 2. are estimated costs to provide services. If the fees or service charges create revenues in excess of actual cost, those revenues shall be used to reduce the fee or service charge creating the excess.
