**NOTICE TO PROPERTY OWNERS OF
PUBLIC HEARING**

**November 14, 2022 at 11:00 am
ON PROPOSED 2023 RATES, FEES,
AND ASSESSMENTS**

Overview

The Root Creek Water District (District) sustainably manages surface water and groundwater resources to provide available water supply for Agricultural and Municipal customers within the District. The District imports and delivers surface water to agricultural customers and simultaneously provides potable water, stormwater and sewer services to municipal customers. The District intends to adopt a 2023 rate schedule to recover the District’s share of providing agricultural and municipal services. Rates proposed for years following 2023 are listed for informational purposes only.

The District completed a Municipal Rate Study Update in 2022, approved by the landowners in the District, to fairly determine the costs and rates for agricultural water service and municipal (Riverstone development) utility services. The costs found in Table 1., Table 2., Table 3., Table 4., and Table 5., are the estimated costs to provide services. Rates are effective January 1, 2023.
