

NOTICE TO PROPERTY OWNERS OF PUBLIC HEARING June 9, 2025 at 11 am Meter Installation Fees Construction Inspection Fees

Overview

The Root Creek Water District (District) sustainably manages groundwater resources to provide available water supply for Agricultural and Municipal customers within the District. The District provides drinking water, storm drain and wastewater services to municipal customers. The District intends to adopt an increase in inspection and meter rates to recover the District's share of providing inspection of construction activities and meter installation.

A Miscellaneous Service Fees Report (October 2017) fairly determined the costs and rates for conducting inspections of construction activities and facilities within the District boundary. Increased labor costs have caused an increase in construction inspection rates. Increased costs from the meter supplier have prompted an increase in the meter fees. The costs found in Table 1. and Table 2. are estimated costs to provide services. If the fees or service charges create revenues in excess of actual cost, those revenues shall be used to reduce the fee or service charge creating the excess.
